# **ORDER**

This is an application seeking regular bail filed under Section 439 of the Code of Criminal Procedure.

- 2. The petitioner is accused No.1 in Crime No.45/2022 of Cheranelloor Police Station. The offences alleged against the petitioner are punishable under Sections 406 & 420 r/w Section 34 of the Indian Penal Code.
- 3. The prosecution case is that the petitioner along with other accused with intent to obtain wrongful gain to them and to cause wrongful loss to the State Bank of India, Changampuzha Branch, entered into a criminal conspiracy and in pursuance of the said conspiracy withdrew Rs.19,000/- on 10.12.2021 by using the ATM Card belonging to the petitioner.
- 4. The petitioner was arrested on 10.02.2022 and has been in judicial custody since then.
  - 5. Heard the learned counsel for the petitioner

and the learned Pubic Prosecutor.

- 6. The learned counsel for the petitioner submitted that the final report has not been filed so far and the petitioner is entitled to statutory bail.
- 7. The learned Public Prosecutor, upon instructions, submitted that the final report has not been submitted in this case. Therefore, the petitioner is entitled to statutory bail.
- 8. In the result, this Bail Application is allowed as follows:
  - (a) The petitioner shall be released on bail on his executing bond for Rs.50,000/- (Rupees Fifty Thousand only) with two solvent sureties each for the like sum to the satisfaction of the jurisdictional Magistrate.
  - (b) He shall appear before the Investigating Officer on all Mondays and Fridays between 10 A.M. and 11 A.M. for a period of three months or till the final report is filed, whichever is earlier.

(c) He shall not try to influence the prosecution witnesses or attempt to tamper with the evidence.
