2. In the instant petition, the petitioners' services were

engaged for spraying D.D.T. under the National Malaria Eradication Programme.

3. The petitioners have earlier approached this Court

vide C.W.J.C. No. 13301 of 2014. This Court vide order dated



12.09.2018 specifically directed the concerned respondents to reconsider the grievance of the petitioners for the purpose of regular appointment. One of the criteria for the purpose of regularization is a temporary employee must have worked 240 days in a calendar year.

4. Undisputedly, the petitioners have not worked 240 days in a calendar year. Therefore, there is no infirmity in the impugned order at Annexure-9.

5. Accordingly, the writ petition stands dismissed.
