Heard learned counsel for the parties.

2. Short question for consideration in the present petition is whether the petitioners are entitled to interest on arrears amount including D.A. on account of extending 5<sup>th</sup> Pay Commission.



- 3. The respondent Corporation was stated to have adopted 5<sup>th</sup> Pay Commission introduced in the year 1997, in the year 2004, whereas the petitioners have been extended the arrears of amount with reference to 5<sup>th</sup> Pay Commission in 2016-17. Therefore, question remains is whether the petitioners are entitled to interest from 2004 to 2016-17 or not?
- 4. In this regard, the petitioners were stated to have submitted representations, which are Annexure-2 series, the same shall be taken into consideration by the competent authority and decide the same in accordance with law. If the petitioners are entitled to interest, the same shall be calculated and disbursed. If they are not entitled, speaking order shall be passed and communicate to the petitioners.
- 5. The above exercise must be completed within a period of four months from the date of receipt of a copy of this order.
  - 6. The writ petition stands disposed of.
