Petitioner has prayed for the following relief(s):-



1. That the petitioner is seeking kind indulgence of this Hon'ble Court for a writ in the nature of mandamus commanding the respondents to immediately call for and hold a free and fair election of the trade union namely The Munger Tobacco Manufacturing Worker's Union, Basudeopur, Munger bearing Registration No.-68.

And;

Any other appropriate writ/writs, order/orders or direction/directions as your lordship deems just and proper in order to improve the collective negotiating/bargaining capacity of the workers of

Indian Tobacco Company (I.T.C.) Limited Munger for their welfare and social security.

Having heard learned counsel for the petitioner, we are of the considered view that the present petition is totally misconceived and as such only merits dismissal.

The dispute is *inter se* the workers in relation to the management and affairs of the Union formed and registered under the Statute. The petitioner has grievances, if any, of the private respondent no. 7, not having conducted any election of the union, can be best raised and addressed before the appropriate authority provided under the Trade Union Act, 1926 and not by way of the instant petition filed in the nature of public interest litigation.



As such, instant petition stands dismissed.

Interlocutory application, if any, shall also

stand disposed of.
