This Criminal Petition, under Section 438 of the Code of Criminal Procedure, 1973 (tCrPC), is filed by the Petitioners/A.4 and A.5 in Crime No.8 of 2023 of Chillakallu Police Station, NTR District, registered for the offence punishable under Sections 498-A, 452, 427, 354, 323, 506 read with Section 34 of the Indian Penal Code, 1860 (qPCJ) and sections 3 and 4 of the DolWry

Prohibition Act,1961, seeking anticipatory bail.

O3. Brief facts of the, prosecution case is that the marriage of the de facto complainant and Bathini upender (A. 1 herein) was solemnized at about eight years ago, thereafter they were blessed with two children. A.1 who is the husband of the de facto complainant addicted

On 02.01.2023 while the de factO Complainant stays at her parents house, A.1 to A.5 tress passed into the house and abused her in filthy language and beat her, thereby She lodged complaint.

o4. In view of the above faCt`; and Circumstances, this court is inclined to grant-antiCiPatOry bail to the petitioners/A.4 and A.5, however, on Certain conditions.

o5. Accordingly, in the event Of their arrest in connection with crime No.8 of `2023 of Chillakallu Police station, NTR District, the Petitioners/A.4 (Podili Rattanma) and A.5 (Nayini Durga_) shall be released on bail on executing a Personal bond for a Sum Of Rs.10,000/-(Rupees Ten Thousand only) each, with two sureties for the like sum each tO the Satisfaction Of the arresting police officials and `also on condition that the petitioners/A.4 and A.5 shall make themselves available for investigation as and when required and that they shall `-. E= .-/ L', CRLP 3606 2023 GRKP, I not cause any threat, inducement or promise to the Prosecution witnesse§'.

O6. The Petitioners shall appear before the station House Officer COnCemed on every Sunday in between 10.00 A.M., and 5.00 P.M., till filling of Charge Sheet.

07. Accordingly, the Criminal petition is allowed. Miscellaneous applications, if any, pending in this Criminal petition shall stand closed.
