The Judgment of the Court was delivered by

PRAKASH D. NAIK, J.:— The applicant was granted bail on medical condition vide order dated 12.6.2023. Subsequently, vide order dated 7.8.2023, it was extended till today.

- 2. Learned counsel for the applicant has produced latest medical case papers which indicate that surgery of the applicant has been deferred as blood sugar is still not under control.
- 3. Learned counsel for the applicant submits that undisputedly applicant is suffering from diabetes and unless the blood sugar is brought under control, it is difficult to perform surgery. He further submitted that compared to the earlier report sugar level was reduced and hence temporary bail granted by this Court may be extended by three months.
- 4. Learned Public Prosecutor submitted that on the basis of the medical case papers produced by the applicant, bail cannot be extended for substantial period of time. At the most by way of last chance bail may be extended by period of four weeks.
- 5. Perused the previous orders passed by this Court and the observation made with regard to ailment of the applicant. From the medical case papers, it is apparent that applicant is undergoing treatment and surgery could not be performed on account of fact that blood sugar level is not under control.
- 6. In these circumstances, presently, bail is extended for a period of two months.
- 7. It is pointed out that so far three to four witnesses are examined. Trial Court is requested to proceed with the trial expeditiously. It is expected that the defence and prosecution will cooperate with the trial
